2. Barriers and options for facilitating psychiatric consultations (Lisa Letourneau and Amy Belisle)

Two priorities that came out of this discussion were:

- 1. The promotion of collaborative care and payment, what are the requirements?
- 2. Figuring out the e-consults

Concerns that were raised:

- 1. The decrease in mental health services across the state has pushed medication management over to the family physicians.
- 2. We need better cell and internet connections.
- 3. We need to extend this service into the emergency rooms
- 4. The challenges surrounding billing under section 65 or 90 and how onerous it can be. Section 65 is very hard to operate under. The decision was made to create a smaller workgroup to talk about the rules to see if there are ways to better align what's currently happening around consults and collaborative care with how they're really operating.
- 5. Need to fix the community psychiatry
- 6. Confidentiality rules and privacy laws in Maine are very strict
