# Department of Health and Human Services (DHHS)

Maine DHHS, the Department of Health and Human Services in Maine, provides supportive, preventive, protective, public health and intervention services to children, families and adults, including the elderly and adults with disabilities.

## Child Welfare Services

Seeks safety, wellbeing and permanent homes for children. working with professionalism and respecting the dignity of all families. Child abuse reports are investigated on behalf of Maine communities, working to keep children safe and to guide families in creating safe homes for children.

# Early Care and Education

## Associate Director: Elissa Wynne

Oversees the Child Care team manages the Child Care Subsidy Program that helps eligible families pay for child care so they can work, go to school, or participate in a job training program.

# Children's Licensing and Investigation

## Janet Whitten, Program Manager

This specialized team licenses, monitors and investigates child care programs, children's residential facilities, child placing agencies, emergency shelters, and homeless shelters for youth. This program conducts child abuse and neglect investigations in a wide variety of out of home settings subject to licensure.

# Staffing Team- CBHS

## Associate Director Medical Director

### **System of Care Team**

Federally funded the increase of family and youth peer support services statewide, evidence-based trainings for community providers and DHHS staff support high-quality of service delivery by MaineCare providers. OCFS used this grant to rebuild the Quality Assurance (QA) team in order to ensure better outcomes for youth.

## **Residential Specialists**

These positions aid children's residential providers in meeting high quality standards. There are two specialists for in state providers and one designated for the OOS providers. They convene meetings among providers, assess their progress on implementation, review treatment quality, data, and provide technical assistance to providers.

### **Family Specialists with Lived Experience**

Two Family Specialists with lived experience with the behavioral health system available to support families with accessing services. They specifically assist families with applying for MaineCare, transitioning to adult services and getting connected with care coordination.

## **Behavioral Health Program Coordinators**

Liaisons with the Department of Corrections (DOC) that sit in the local DOC offices

All BHPCs are co-located with Child Welfare staff

Assist with children who need higher level of services, are in crisis, need to transition to adult services etc.

## Staffing Team- CBHS

#### **Resource Coordinators**

One per region, they monitor service needs to identify areas of the state that need a specific service and then work with providers to start or expand services in that area.

This team is responsible for finding, growing, training and vetting new MaineCare providers ensuring the providers are ready to provide the service, have orientation and training and understanding of the policy and service delivery expectations.

They also work with providers to meet the individual needs of children in need of services.




# Expand the Use of Evidence-Based Models and Evidence-Informed Interventions

DHHS believes that high quality, evidence-based services, implemented to fidelity, improve outcomes for children and families in Maine. Those italicized have been added to the MaineCare Benefits Manual.

## **Enhance the Children's Crisis System**

- Through the American Rescue Plan, the federal Center for Medicaid Services (CMS) requested applications from State Medicaid Authorities for competitive planning grants to support development of community-based mobile crisis intervention services for Medicaid beneficiaries experiencing a mental health or substance use disorder (MH/SUD) crisis
- Maine was one of 20 awardees for the grant period September 30, 2021 September 29, 2022
- DHHS participating offices include OMS, OCFS, OADS, OBH, CDC
- Extensive stakeholder engagement
- MaineCare billable crisis services will undergo a rate study and policy updates which will minimally include the CMS required components:



# Maine Crisis Line "The Gateway to Acute Service"



FREE. CONFIDENTIAL. AVAILABLE 24/7.

- What It Is: Trained behavioral health professionals who provide support and consultation to Mainers experiencing immediate mental health crisis either in person or by phone. Statewide Mobile Crisis Services are available 24/7 via the hotline providing immediate, crisis-oriented support, triage, and assessment and follow up focused on the immediate stabilization of the crisis.
- Who Is Eligible: All Mainers experiencing a mental health crisis and are in need of supportive de-escalation, stabilization, suicide prevention, and connection to ongoing care as needed. They may be an immediate risk to themselves or others.
- How To Access It: Call the statewide crisis hotline at 1-888-568-1112

# Key Strategy Progress Updates

- In 2020 OCFS launched a pilot program which provided **Aftercare services** for youth and family members when youth are transitioning home from emergency departments, psychiatric hospitals, crisis stabilization, and residential treatment
- The goal of the pilot is to decrease the number and length of youth's stays in these out-of-home settings.
- As of March 2022, the original pilot site served 108 families in Aroostook County and 6 families in Washington County.
  - 88% of families served by the pilot did not go to the ER for crisis once the team was involved
  - 90% youth served by the pilot were able to remain at home due to the service supporting the family 10% of the youth involved went to Crisis Stabilization Unit, Inpatient Psychiatric Unit, or Residential Care
- By braiding funding sources, OCFS was able to expand the pilot statewide through the end of State Fiscal Year (SFY) 23 to align with the CMS Crisis Planning grant work
- The service components of the Crisis Aftercare pilot and the pilot outcome data are being assessed to determine if they are eligible to be incorporated into the Medicaid crisis services policy

## What the Grant Does



### TARGETED CASE MANAGEMENT (TCM)

## WHAT IS TARGETED CASE MANAGEMENT?

TCM is a service that provides a community Case Manager\*, to help a youth and their family identify their strengths and needs, develop a care plan, and implement the plan to assist with finding and connecting them to helpful resources and treatment services for their child. The Case Manager also helps monitor and follows up on the effectiveness of a youth's services and supports.

\*This is different from a school-based case manager.

#### WHO IS ELIGIBLE?

A child or youth aged 0 – 21 with MaineCare or youth under age 19 with the <u>Katie Beckett waiver</u> and a mental health diagnosis, an intellectual disability, or a developmental disorder.

#### HOW DOES IT HELP?

A Case Manager can help:

- Identify the child and family's strengths and needs for medical, educational, social, or other services
- Assist with creating a plan to support and address those needs
- Identify a variety of appropriate and available resources
- Identify treatment services and make referrals to services
- Set up appointments
- · Coordinate and monitor services
- Family members with organizational tasks and skills, including paperwork, attending meetings to support the youth's needs including, when appropriate, IEP meetings, and/or advocating for family and child needs
- Educate families and children on services and systems

#### HOW TO ACCESS TCM



# Early Childhood Consultation Project (ECCP)

ECCP® is a **time-limited**, intensive service that helps **childcare providers**, **educators**, **and caregivers** of young children build understanding and skills to respond to the social-emotional needs of children.

Mental health consultants work directly with caregivers and educators to identify and implement strategies to support children's emotional wellbeing and effectively manage challenging behavior that may jeopardize a child's ability to attend an early childhood program or educational setting.

Core Classroom& Child-Specific Services offered

Open to any eligible child, 100% state-funded service

- Children **0-5 years** (up to age 8 starting spring 2022)
- Enrolled in childcare center, family childcare, or public Pre-K
- Social-emotional issues, behavioral concerns, and/or normal developmental challenges
- Child maybe at risk of suspension and/or expulsion from childcare program
- Childcare provider AND parent/guardian agree to participate
- Not formally diagnosed with MH or ID/DD concern, not receiving concurrent MH or ID/DD services (OP, Sect 28, HCT)
- As of March 2022, 98% of individual children served through March 2022 were not suspended/expelled at one-month follow up

# Help Me Grow Maine

## A Solution to Help Young Children Shine

Help Me Grow is a system model with a central access point that is designed to connect families to information and services about child development and community resources.

In partnership with 2-1-1 Maine, any parent and/or provider will be able to contact Help Me Grow for additional support as Help Me Grow will listen, link you to services, and provide ongoing support.

## **HOW IT WORKS**



#### **Centralized Access Point**

Assist families and professionals in connecting children to the grid of community resources that help them thrive.

#### Resources

Help Me Grow builds an effective grid of connected service providers that best serves families within the state of Maine.

## **Developmental Screening**

Maine utilizes the Ages & Stages Questionnaire (ASQ-3) to assess a child's communication, motor skills, problem solving, and personal social skills.

### **Eligibility**

A free universal service available to all children, prenatal to eight years of

OCFS coordinates a quarterly stakeholder group of 75+ individuals working on Youth SUD from various communities including medical professionals, behavioral health providers, advocates, legislators, and teachers.

#### Project ECHO on Adolescent MOUD: Learning objectives:

- Bolster skills to appropriately identify and treat SUDs within adolescent populations including specialty populations of adolescent girls and LBGTQ+ populations;
- Build competencies to deliver traumainformed SUD/MAT care from screening to navigating consent and confidentiality to treatment;
- Strengthen confidence to deliver integrated MAT services in the adolescent population; and
- Expand understanding of harm reduction practices in the adolescent population.


## **Ongoing OCFS Projects**

Early intervention and treatment are key components of the SUD continuum of care and essential to preventing youth overdose.

OCFS is working to increase the availability of SUD treatment that embodies System of Care principles.

Adolescent Community Reinforcement Approach (A-CRA) Training:

- What it is: Developmentally-appropriate, effective Youth SUD / co-occurring treatment modality
- Target participants: Children's Residential Care Facilities & Specialized Youth SUD facilities
- Key training components: The training will be offered at no-cost to providers, and participants will be reimbursed for their time.
- OCFS plans to train 18 clinicians and 9
   supervisors in A-CRA in SFY 23.

Youth Peer Support Statewide Network

#### Youth Peer Support Statewide Network now accepting referrals for youth peer support!

Maine Behavioral Healthcare was awarded a new contract with the State of Maine to develop a Youth Peer Support Statewide Network (YPSSN). This program offers anyone in the state of Maine who is between the ages of 14 and 26 access to a variety of peer support opportunities. The contract officially began in February of this year and we are already offering a number of activities for Maine's youth and young adults who are struggling or have struggled with their mental health, which may include substance use. There is no insurance needed, no diagnosis required, and no cost.

The YPSSN has youth peer support staff in Portland, Lewiston and Bangor primarily. We also will have staff in Piscataquis, Aroostook, and Penobscot Counties offering support to youth and young adults on waitlists for behavioral health services. Again, this is a statewide program, so youth and young adults from across Maine can access virtual and in-person activities.
